**Notice of Hearing on Special Assessment Roll**  
**Kochville Township Davis Road Water Main Installation**

NOTICE IS HEREBY GIVEN:

1. The Township Board of Kochville Township (ATownship Board@), Saginaw County, Michigan, has declared its intent to make improvements consisting of:

**Installation of a water main on Davis Road, commencing at a point approximately 775 feet south of the intersection of Davis Road and Pierce Road, and terminating at a point approximately 61 feet south of the intersection of Davis Road and Kochville Road.**

2. Plans showing the improvement and its location and a cost estimate in the amount of \$ 475,000.00 are on file with the Township Clerk for public examination.
3. The Township Board has designated the following assessment district against which part of the cost of the improvement is to be assessed:

An area located in Sections 25 and 26, T13N-R4E, Kochville Township, Saginaw County, Michigan lying 300 feet East and 300 feet West of the North/South Section line of Sections 25 and 26 (Davis Road) more particularly described as:

Commencing at the Northwest Corner of Section 25 T13N-R4E, Kochville Township, Saginaw County, Michigan (also the Northeast Corner of Section 26 T13N-R4E); thence along the West Section line of said Section 25, Southerly, approximately 783 feet to the POINT OF BEGINNING, thence Easterly, approximately 300 feet; thence parallel with the West Section line, Southerly approximately 1835 feet to the North/South  $\frac{1}{4}$  line of Section 25 and Liberty Road; thence continuing parallel with the West Section line, Southerly, approximately 2,625 feet to the South line of Section 25 and Kochville Road; thence along the South line of Section 25, Westerly, approximately 300 feet to the Southwest Corner of Section 25, thence along the South line of Section 26, Westerly 300 feet, thence parallel with the East line of Section 26, Northerly, 2,626 feet to the North/South  $\frac{1}{4}$  line of Section 26 and Liberty Road, thence continuing parallel with the East line of Section 26, Northerly, approximately 1,833 feet, thence Easterly, 300 feet back to the POINT OF BEGINNING

4. The Special Assessment Roll for the Assessment District in the amount of \$496,063.45 has also been filed in the office of the Township Clerk for public examination.
5. The Township Board will meet and hold a hearing at the Kochville Township Veteran's

Hall, 3265 Kochville Road, Saginaw, Michigan on the 19th day of November, 2018, at 7:00 p.m., Michigan Time, for the purpose of reviewing and considering any objections to and confirming the special assessment roll. Appearance and protest of the special assessment at the hearing is required in order to appeal the amount of the special assessment to the Michigan Tax Tribunal. An owner of or party in interest in the property to be assessed, or his or her agent, may appear in person to protest the special assessment, or may protest the special assessment by letter filed with the Township Clerk at or prior to the time of the hearing, in which case appearance in person is not required. If the special assessment is protested as provided above, the owner or any party having an interest in the real property may file a written appeal of the special assessment with the Michigan Tax Tribunal or other court of competent jurisdiction within thirty (30) days after the confirmation of the special assessment roll.
